With reference to above mentioned subject, it is mentioned that, in accordance with decision of State Government referred to Department of Marathi Language No. MSN-2016/P.N.60/2016/language-3 dated 13<sup>th</sup> May 2016, Maharashtra State Board of Literature and Culture has undertaken the project 'Editing and Republishing of Books related to Hinduism published between 1864 to 1947'. The said project has been entrusted to you for editing by mutual agreement of 13<sup>th</sup> December 2018. As per said mutual agreement dated 13<sup>th</sup> December 2018, a period of two years has been allotted for the said project and it has been decided to pay you Rs. 12 lacs (Rs. Twelve Lacs only) as honorarium for this project. Accordingly, from the honorarium of Rs. 12 Lacs (Rs. Twelve Lacs only) fixed for said project, first installment of Rs. 6 Lacs (Rs. 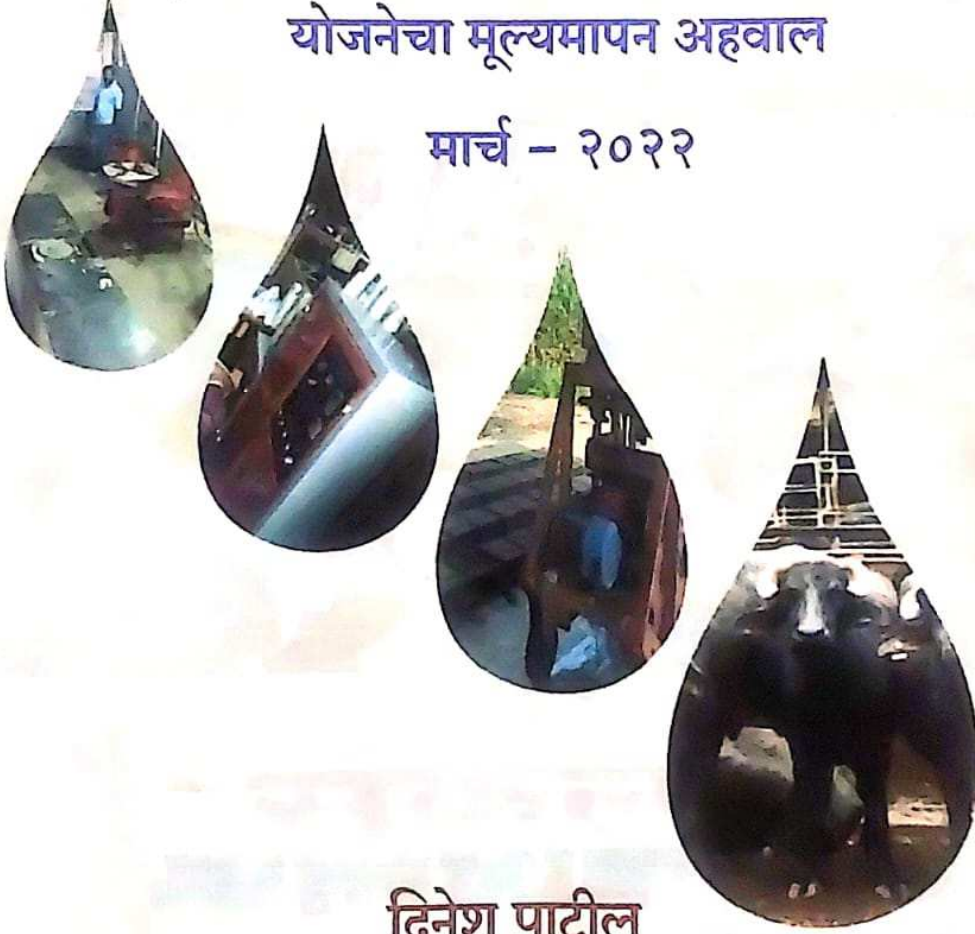
